Thursday the 28th of December 2023 at 5:35 p.m. in the Hall of Flags, in Campidoglio the Capitoline Committee of Rome gathered composed of:

**Discipline and management of sponsorship – Ambit and intervention area approval.**

Assuming that,

with the Capitoline Assembly Deliberation n.23 of the 7th of march 2019 the new Regulation on the Discipline and Management of Sponsorship has been approved (hereafter Regulation) and contextually repealed the City Council Deliberation n. 214 the 15th of November 2004 of the previous “regulation on the discipline and management of sponsorship approval;

according to art. 4 of the Regulation the scopes and areas of intervention subject of the sponsorship are identified annually by the Capitoline Committee, in accordance with the Institutional planning documents;

with the purpose to implement the regulatory provisions, with circular prott. n. SU/14094 of the 13/09/2023, and n. SU/15409 of the 05/10/2023, The Contracts Central Department required to the different Roma Capitale Structures, with a reconnaissance aim, to identify possible spheres of interest and areas of intervention in order to activate sponsorship contracts and to submit them to the Capitoline Committee attention;

the Capitoline Structures that identified the aforementioned spheres and initiatives were: The Capitoline Superintendence, the Civil Protection Department, the Major Events, Sport, Tourism and Fashion Department, the Roma Capitale Local Police Corps, the Heritage Enhancement and Housing Policies Department, City Halls Roma VI, Roma IX, Roma X, Roma XI, Roma XIII and Roma XV;

the Capitoline Structures below, while providing feedback to the aforementioned circulars, they however have not identified spheres or performances to activate sponsorship contracts: the Mayor’s Cabinet Management Offices I, IV and V, the Mayor’s Cabinet “Youth Politics” Purpose Office, the Capitoline Assembly Office, the General Secretariat, the Organization and Human Resources Department, the Economic Development and Productive Activities Department, the Digital Transformation Department, the Equal Opportunities Department, the Sustainable Mobility and Transports Department, the Coordination Infrastructure Development and Urban Maintenance Department, The Capitoline Formation School, City Halls Roma XII and Roma XIV;

the Environmental Protection Department communicated it had received during the year technical sponsorship request especially for enhancement and maintenance of public green areas and related equipment - including the recreational and sports areas - and it had published a specific Notice related to “fence installation and green area maintenance at Marmorata street” already included in the attachment of the previous Capitoline Committee Deliberation n. 134 of the 20<sup>th</sup> of April 2023;

the Major Events, Sport, Tourism and Fashion Department specified that only one initiative has been indicated, replicated for each year of the three-year programming plan 2024-2026, because the information and the indication they currently have in their possession, “related to different spheres of interest, such as

major events realization, the promotion of tourism, sport and fashion or the sport systems exploitation, do not reach, at this stage, the level of detail that would allow [ed. them] to outline an eventual fundraising plan;

the City Hall Roma XII, communicating that no spheres or areas of intervention have been identified, and no request have been received yet from public or private organization, specified that spheres related to the maintenance of the public areas and municipal parks are currently under investigation by the Technical Direction;

the Capitoline Formation School, while not planning any sponsorship contract, has communicated that in relation to the needs of the same Structure the only sphere of intervention could be the possibility of activating a technical sponsorship for the creation of 4.0 classrooms at the Largo Ascianghi site;

considering that,

the art. 4 paragraph 1 of the Regulation also provides that the Capitoline Committee can formulate specific addresses for the activation of sponsorship initiatives that arise subsequently the approval of the aforementioned Institutional planning documents,

according to the Contracts Central Department reconnaissance activity is possible to identify the following spheres or areas of intervention deduced from the proposals received from the capitoline Offices and Structures:

Urban redevelopment;

Redevelopment of real estate property;

Supply and Maintenance of furniture and equipment in green, recreational and sports areas (e.g. baskets, benches, toys etc.);

Green area maintenance (e.g. green area maintenance, planting of bushes and flowers, planting of arboreal essences, creation of an irrigation system, etc.);

Restoration and enhancement of cultural heritage;

ancillary Services to cultural events and activities;

Supply of Christmas lighting;

Supply of goods for sport and cultural events (e.g. plaques, medals, cups, T-shirts, stages, chemical toilets, audio and video systems, chairs etc.);

Supply of goods, services, works for the civil protection activity;

Within the foretold spheres or areas of intervention, the exact initiative and performance identified by the aforementioned Administration Offices and Structures are contained into the specific List, prepared and

stored in legal deed at the Contracts Central Department Management Office, that will be published into the Transparency -Sponsorship section of the Roma Capitale institutional Portal, with the aim to provide it with the wider diffusion.

If during the year new initiatives and performances should be presented within the above spheres or areas of intervention, the Contracts Central Department will be on charge to realize the new updated List and to proceed with its publication.

considering that on the 23rd of November 2023 the Contracts Central Department Manager expressed the subsequent opinion quoted in full: "According to and as result of art. 49 Law Decree 18 August 2000, n. 267 and subsequent amendments, a favorable opinion is expressed with regard to the technical regularity of the proposed deliberation in object.

Restoration and enhancement of cultural heritage;

ancillary Services to cultural events and activities;

Supply of Christmas lighting;

Supply of goods for sport and cultural events (e.g. plaques, medals, cups, T-shirts, stages, chemical toilets, audio and video systems, chairs etc.);

Supply of goods, services, works for the civil protection activity;

Subsequently, in the cases provided for by current legislation, we update the three-year planning of public works and the two-year planning of goods and services purchase, on the basis of the initiatives that will be identified within the areas defined and in line with the resources planned in the budget.

If during the year 2024 new initiatives and performances should be presented within the above spheres or areas of intervention, the Contracts Central Department will be on charge to realize the new updated List and to proceed with its publication.

*Finally, the Committee, in consideration of the urgency to provide for, unanimously declares this deliberation is immediately enforceable in compliance with the law.*
